



## SUMMER STAFF COVENANT

This document is an agreement between \_\_\_\_\_ and the National Staff of World Changers. When signed by both parties, this instrument becomes a behavioral covenant. Failure to comply with the terms herein may result in early dismissal.

I understand all travel, lodging and meal expenses are paid when I am not at a project.
3. I understand I will not have student missionary secondary insurance with World Changers. I have been advised to carry personal primary insurance. Workers compensation benefits are available.
4. I agree to comply with appropriate dress (see staff manual) and physical appearance for both the World Changers ministry sites and World Changers Gathering environments.

As a World Changers summer staff member, I realize that I am and desire to be an instrument through which the Lord will minister to the needs of students and adults who attend World Changers projects. In order to be spiritually & physically refreshed and at my greatest potential for those I am working with and serving, I will...
  - ...seek the daily renewal of my spirit through the practice of spiritual disciplines during the summer;
  - ...attend all project Gatherings and make myself available for ministry with students and adults;
  - ...refrain from the use of inappropriate and offensive language or behavior;
  - ...refrain from the possession of and consumption of alcohol and the use of tobacco or illegal drugs;
  - ...contribute to the unity of the staff by refraining from the pursuit and development of exclusive relationships;
  - ...be a supportive team member and work quickly and responsibly for the resolution of conflict;
  - ...seek to maintain my physical strength by being in bed at a reasonable hour;
  - ...give myself fully to my staff responsibilities in order that I may grow as a minister in every possible way;
  - ...abstain from wearing excessive earrings or other body piercings during the summer (for female staffers);
  - ...abstain from wearing earrings or other body piercings during the summer (for male staffers);
  - ...not obtain any new body piercing or tattoos;
  - ...abstain from any gambling activity;
  - ...abstain from bringing or purchasing weapons;
  - ...abstain from any other behavior that would bring disgrace to Jesus Christ or World ChangersI agree to be present for all contracted time, unless I have been preapproved for absence because of a major event that involves my immediate family. I have listed those preapproved dates here:
